Michael Gatewood Jr., Director of Internal Auditing, and Kenneth Revels, Business Process Analyst, each played a key role in Lee County's implementation of the SchoolCash platform in 2023.

What is your role with the School District of Lee County and what were your first impressions of SchoolCash?

Michael Gatewood Jr.

I lead a team that works with bookkeepers in our district, auditing the funds they collect at our schools. I have held positions in Finance, HR and Payroll; prior to that, I was an auditor myself.

Kenneth Revels

I've been a Business Process Analyst at the District for two years, primarily assigned to business services. Before taking on this role, I was a bookkeeper for almost 17 years.

School-based staff members are really excited that the catalog can be posted to an online store. Families can go there, see what's available—spirit gear, for one thing—and buy it. I wish we had this when I was operating a school store because we would have made a lot more money.

The old software we were using was crashing all the time, so we were overdue for something new. I told Michael, "If we can just get everybody to buy into SchoolCash, they'll realize how much time it's going to save them and how much better it will be. It's going to make life so much easier for everybody involved."

KEV Group put together a great demo for us. We had 75 bookkeepers at the demo meeting, and they were all really excited about the new system.

What are the main uses for SchoolCash and what do they involve?

The bookkeepers at our schools were using outdated, standalone, DOS-based software so we wanted to bring all of the accounting under one umbrella. Our goal was to centralize the chart of accounts and vendor database in SchoolCash. This would enable us to pull district reporting without having to compile and enter data from every individual location, reducing the workload on our teachers and bookkeepers. SchoolCash also gives us a solution for processing credit card payments, something that parents have

been asking for. Historically, about 90% of the funds we collect have been in the form of cash and checks.

Kenneth Revels

Consolidating all of the accounting in one place is really big for us. In the old system, the vendor list was scattered all over. Trying to go through that list was brutal. When we moved the vendor list into SchoolCash, it was an incredible improvement.

Can you tell us a little bit about your experience with implementation and ongoing support from KEV Group?

Michael Gatewood Jr.

We set up 95 schools in three months. The old software started giving us so many problems, we actually accelerated the implementation, finishing about a month ahead of schedule. We pretty much used SchoolCash right out of the box. Anytime we had a question, somebody from KEV was right there to answer it and walk us through what we needed to do.

I was impressed with the way KEV helped us during the implementation. My boss, the Chief Technology Officer, was very impressed with how fast we were able to implement SchoolCash. It's a solid product.

I think that's what Michael and I appreciate more than anything else. The whole time I was a bookkeeper, I never heard from the previous software provider at all.
